- 7. First public hearing regarding the intent of the City of Bee Cave to annex into the city limits approximately 58.637 acres of land which is generally located on Highway 71 East, east of the current city limits adjacent to the Uplands Subdivision.
- 8. Public Hearing, discussion, and possible action on Ordinance No. 182 amending the Future Land Use Map of Section 8 of the Comprehensive Plan from Medium Density Residential to Neighborhood Service for Lots 1A through 1E, a replat of Lot 1, Block A, Mountain Laurel Subdivision, City of Bee Cave as recorded in Document No. 201300057 of the Official Public Records of Travis, County, Texas to correct errors on the Future Land Use Map.
